**CITY OF CYPRESS
PRE-EMPLOYMENT ADDENDUM FOR
RECREATION & COMMUNITY SERVICES DEPARTMENT POSITIONS**

Pursuant to Public Resources Code Section 5164, the City of Cypress cannot hire a person, or permit a person to volunteer, to perform services at a city operated park, playground, or recreational center used for recreational purposes, in a position having supervisory or disciplinary authority over any minor, if that person has been convicted of any offense specified in paragraph (1) of subdivision (h) of Section 11105.3 of the Penal Code, or some multiple misdemeanor offenses specified in paragraph (3) of subdivision (h) of Section 11105.3 of the Penal Code. We are required to ask you to respond to the following questions. **Please respond to each question below and return this form with your application.** This form is confidential and will not be used for any other purpose.

If you are ultimately selected for a position with CYPRESS, and before you can commence your employment or volunteer service, you will be required to submit to a fingerprint clearance with the Department of Justice (DOJ). Your responses here will be compared to the DOJ report. Any response which is later shown to be untruthful will result in rejection for, or dismissal from, employment.
