SB 1383 Enforcement: Sorting Organic Waste

With 2024 underway, California businesses are now moving into the enforcement phase of SB 1383. This legislation aims to decrease organic waste and its environmental effects. SB 1383 sets ambitious targets: a 75% reduction in organic waste diverting 20% of excess food to communities in need by next year. While 2022 focused on the implementation and education of the organics program, 2024 allows jurisdictions to impose fines on non-compliant entities and for repeated contamination offenses. To comply with SB 1383, businesses must prioritize the correct sorting of organic waste.

What qualifies as food waste?

Food waste includes organic materials like:

- Fruits & Vegetables
- Meat, Fish, & Bones
- Dairy, Bread, & Grains
- Coffee Grounds & Filters

Remember to **exclude** unwanted items like:

- Single-Use Plastics
- Oiapers
- To-Go Cups
- Takeout Containers
- Pet Waste & Litter

Mixing trash items with organic waste can lead to the entire load being tagged as general waste and ending in landfills. This contradicts California's objective to decrease organic waste by 75% by 2025.

By effectively separating organic materials like food scraps, yard waste, and compostable items, businesses not only help achieve SB 1383 objectives but also lessen environmental impact and promote sustainable practices.
