

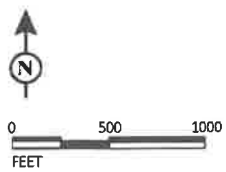

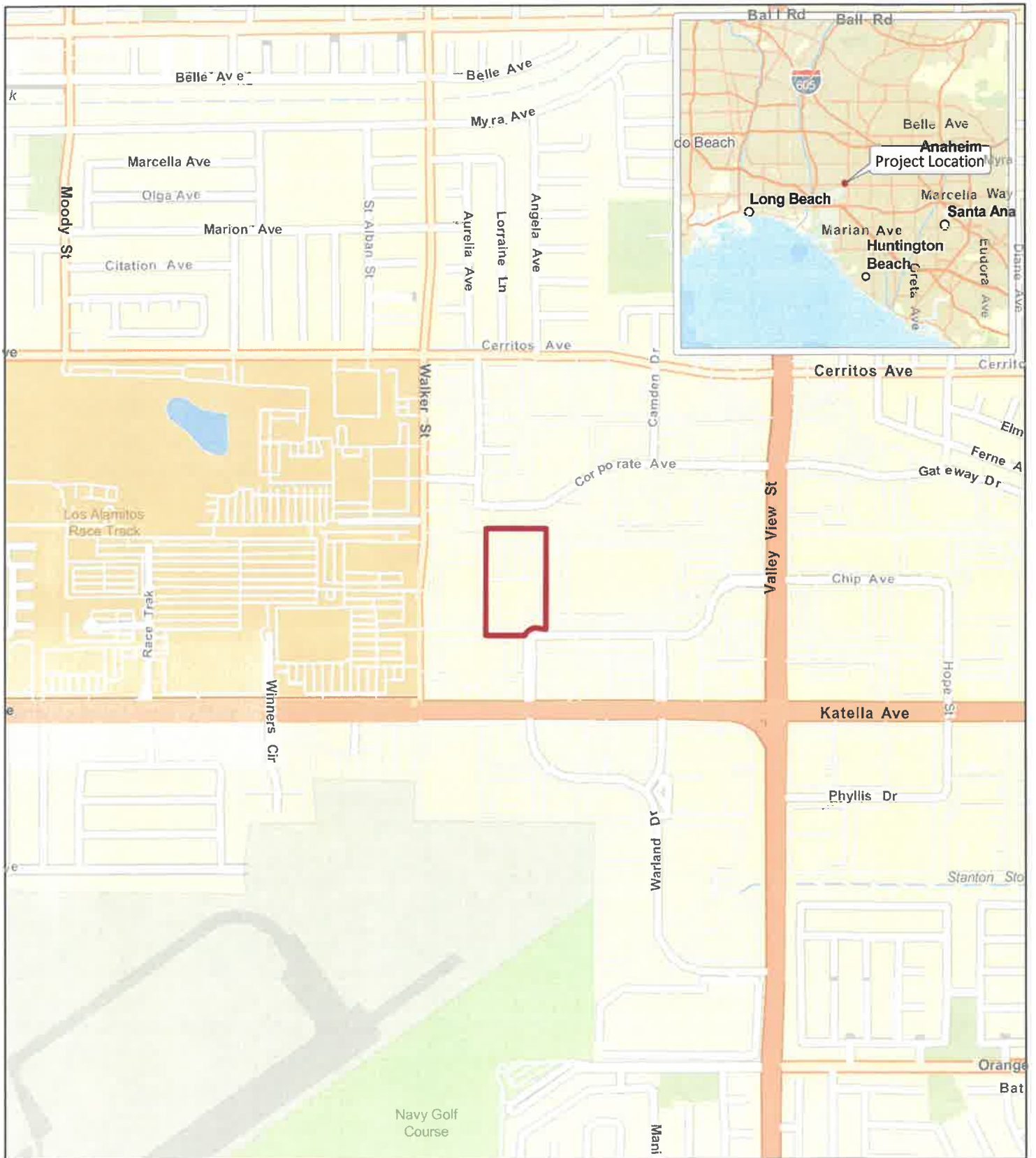

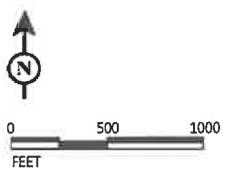
Attachment: Figure 1 –Project Location and Regional Vicinity

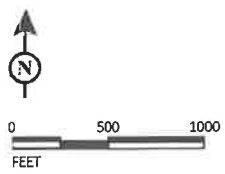

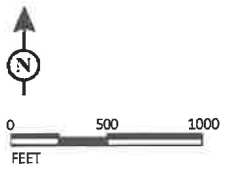
Attachment: Figure 1 –Project Location and Regional Vicinity

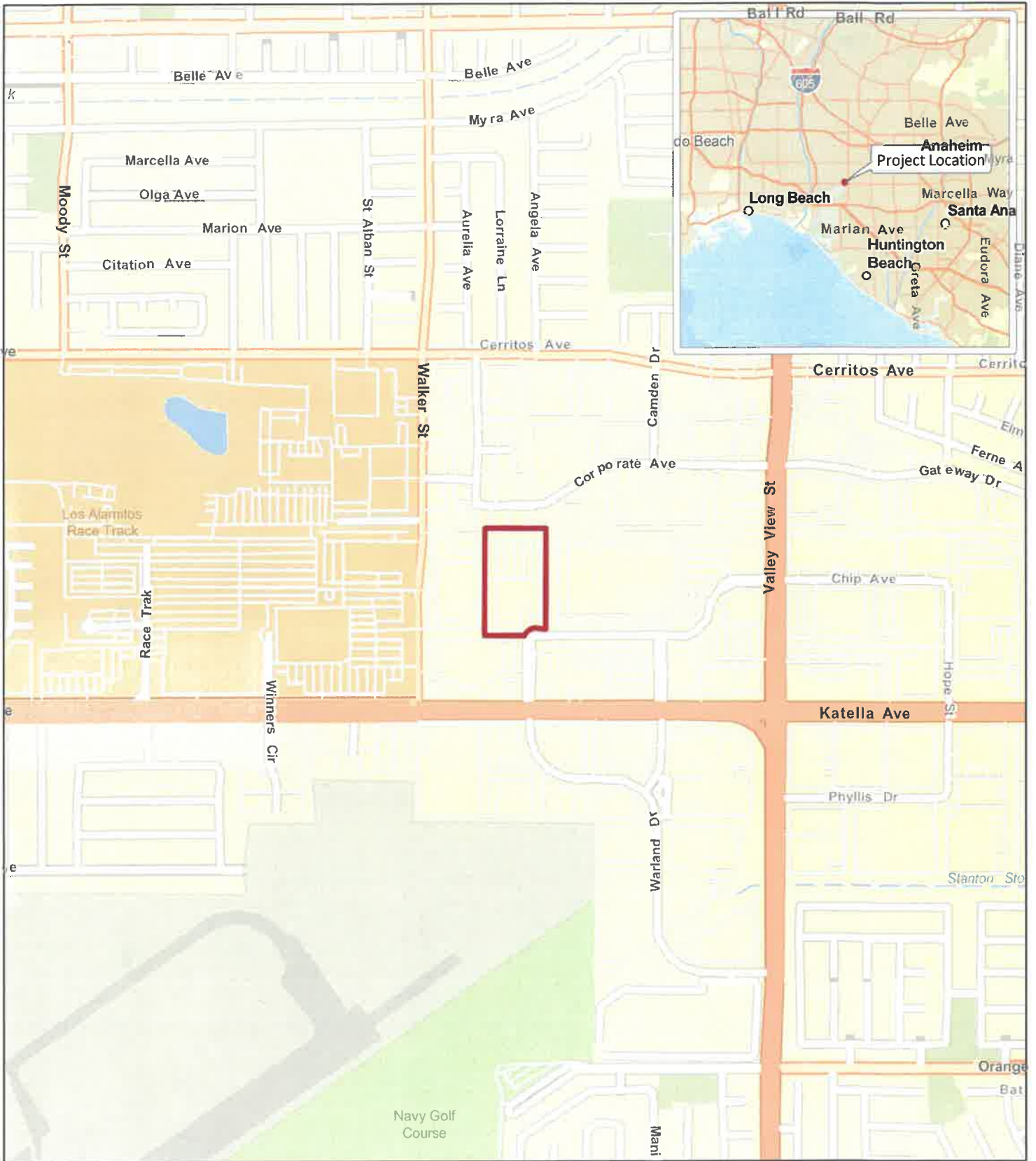

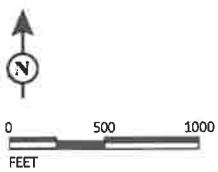
Attachment: Figure 1 –Project Location and Regional Vicinity

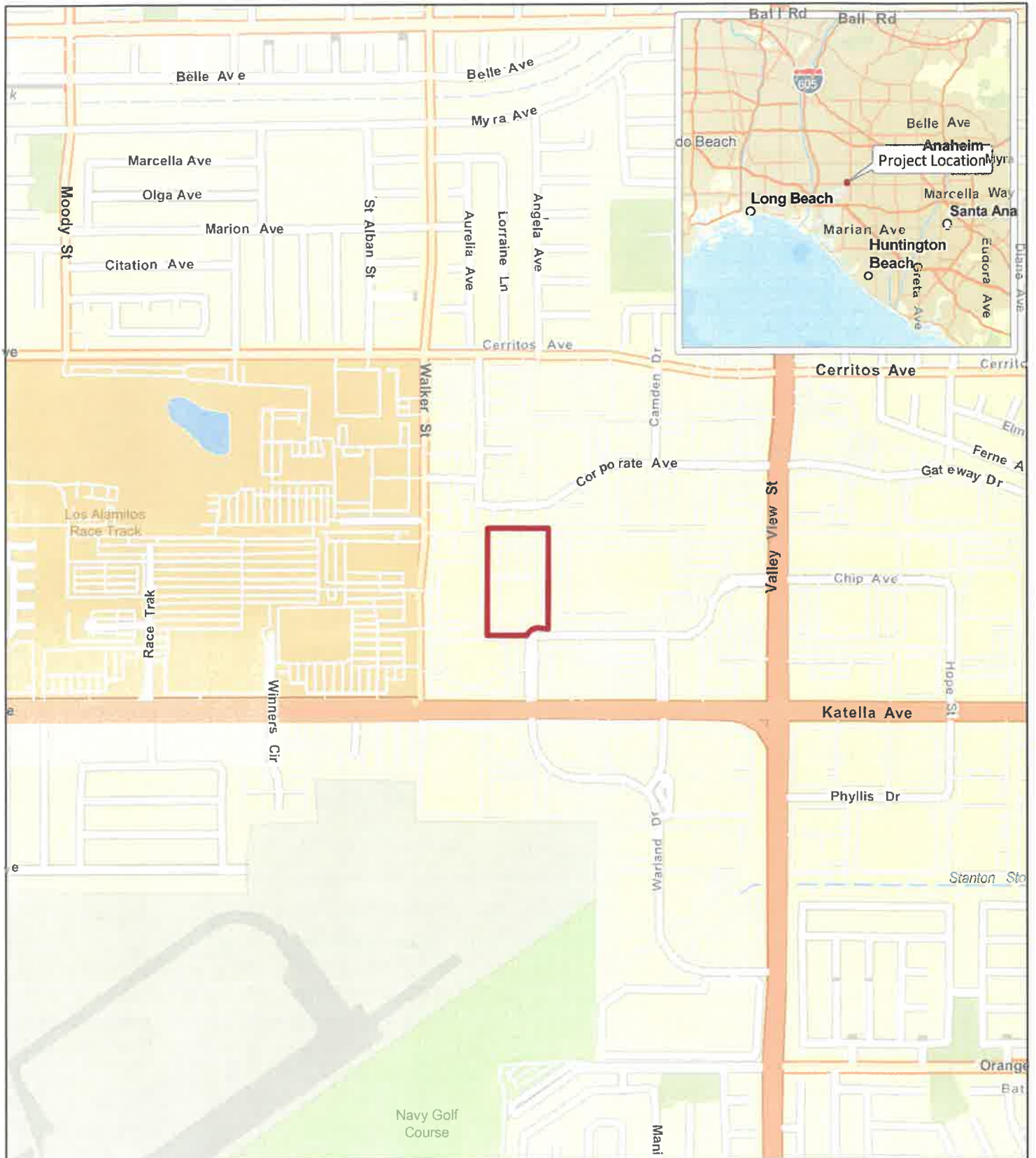

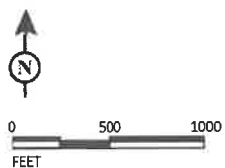

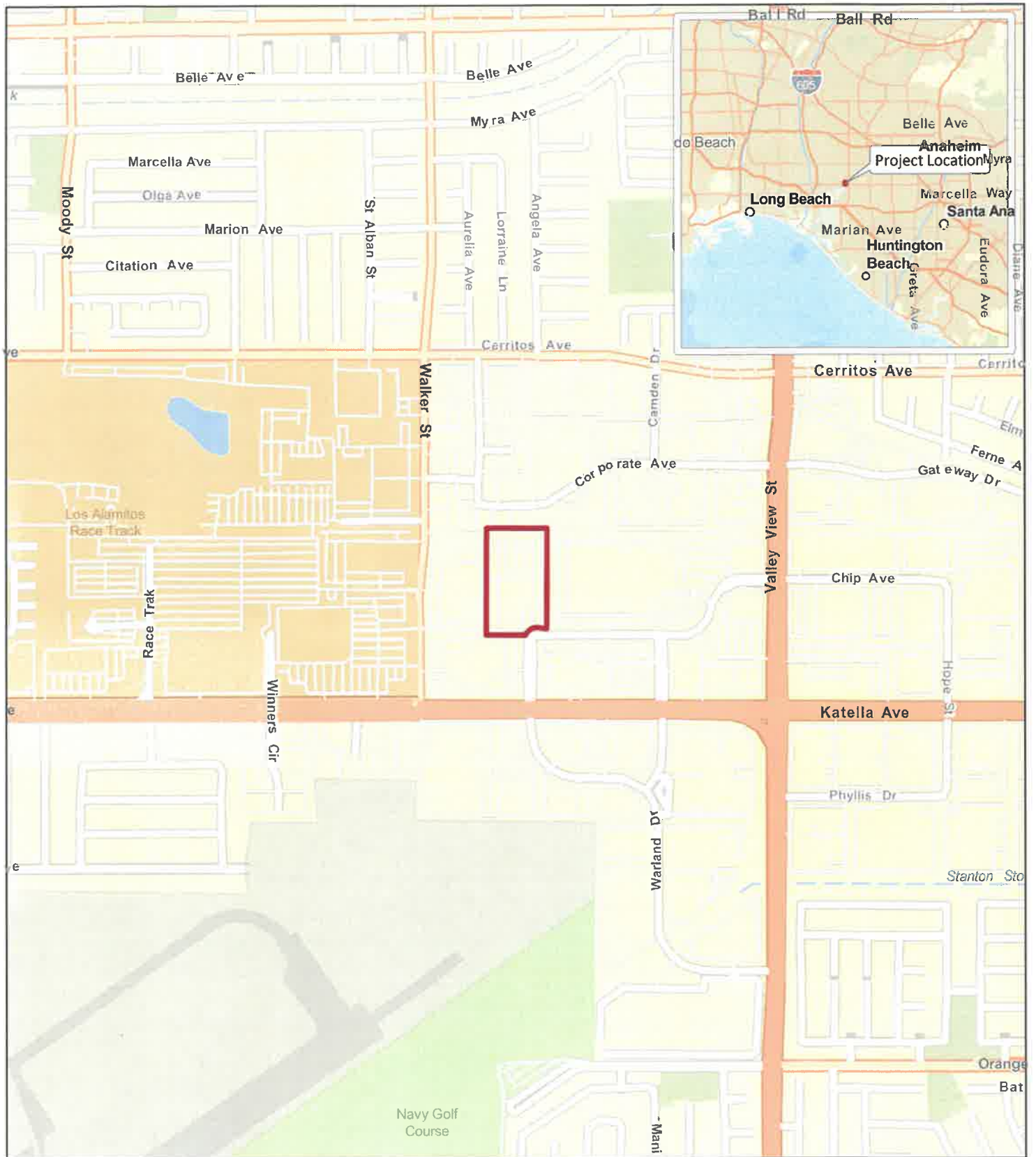



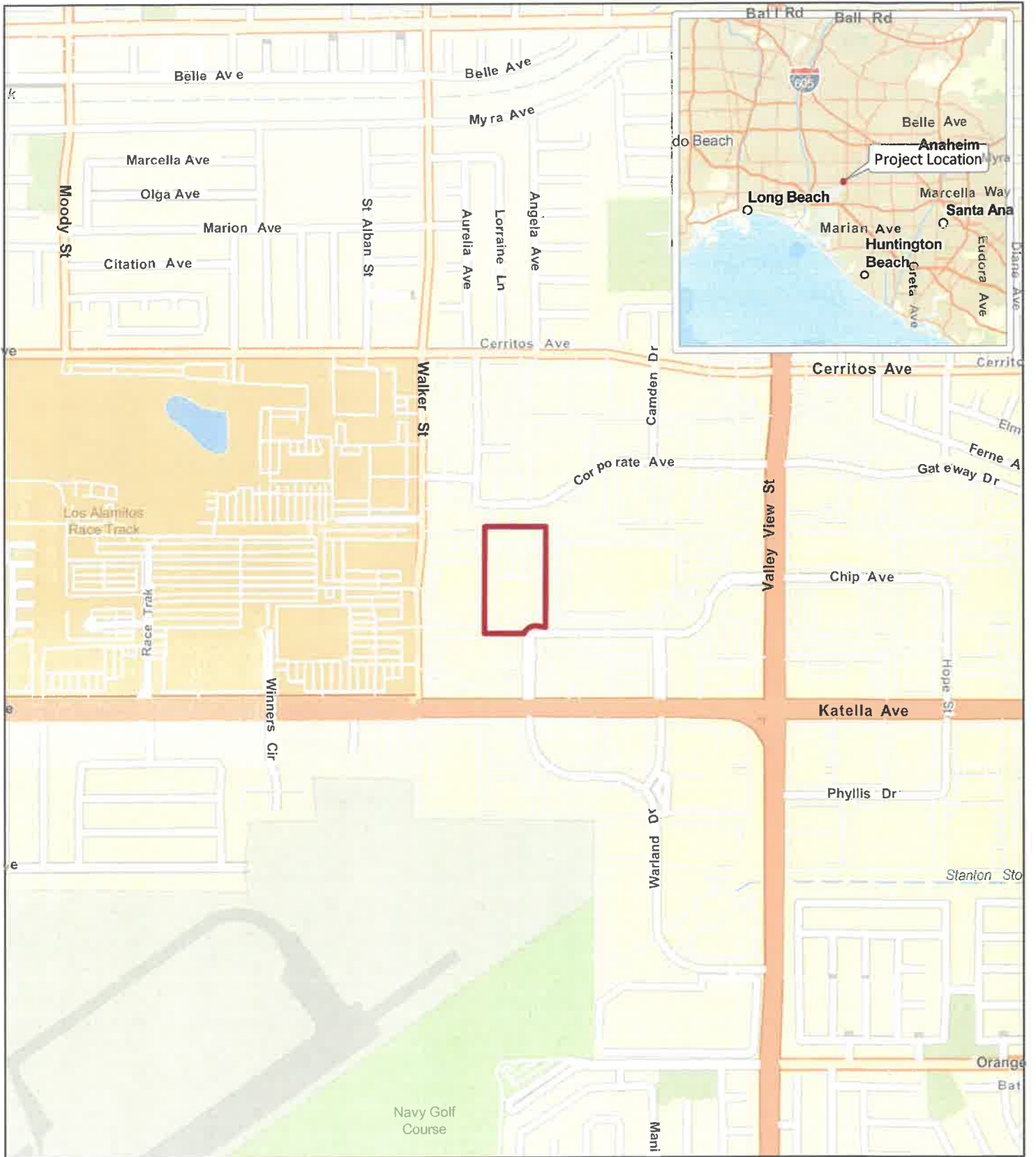

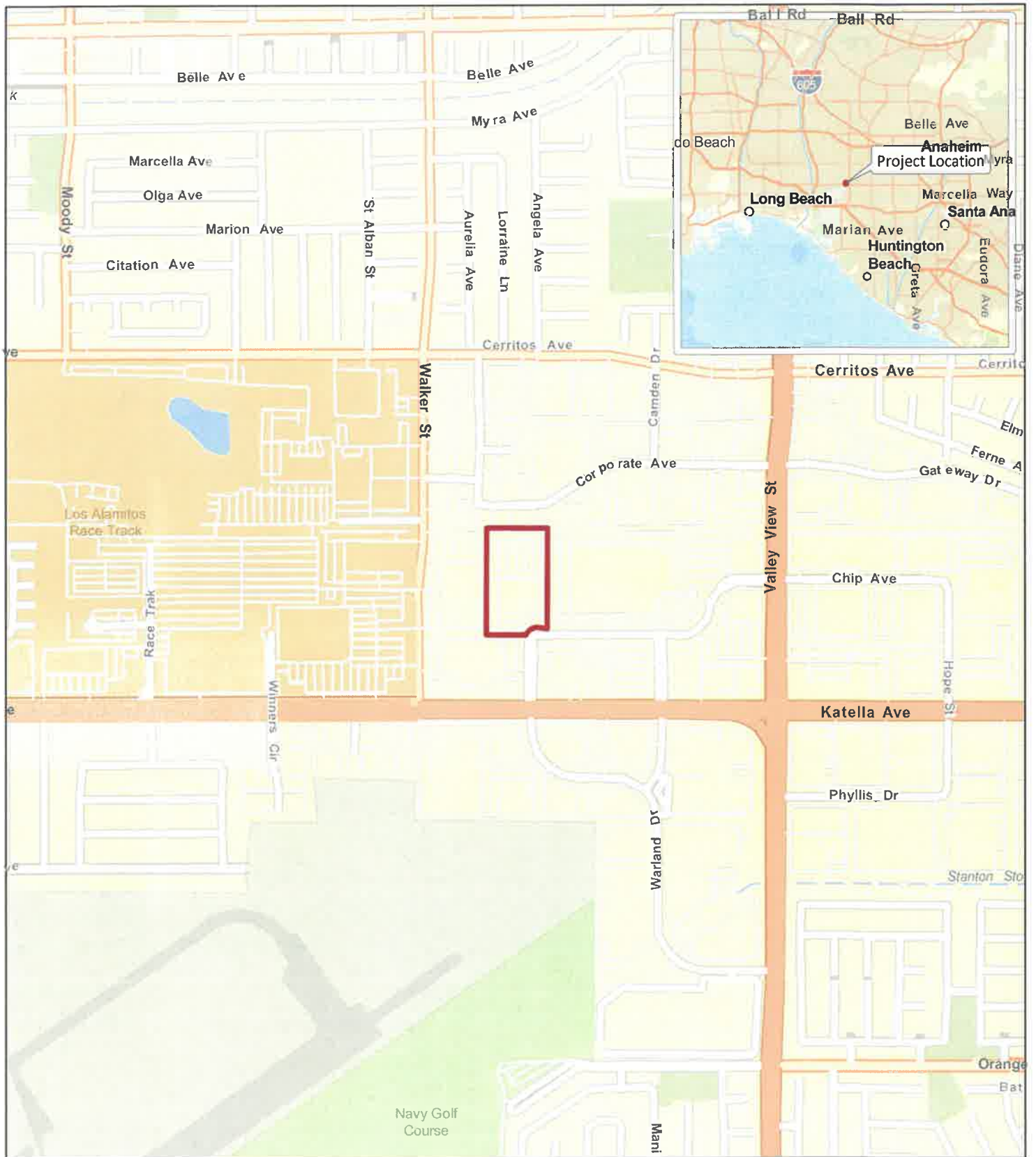

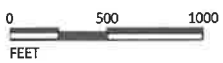

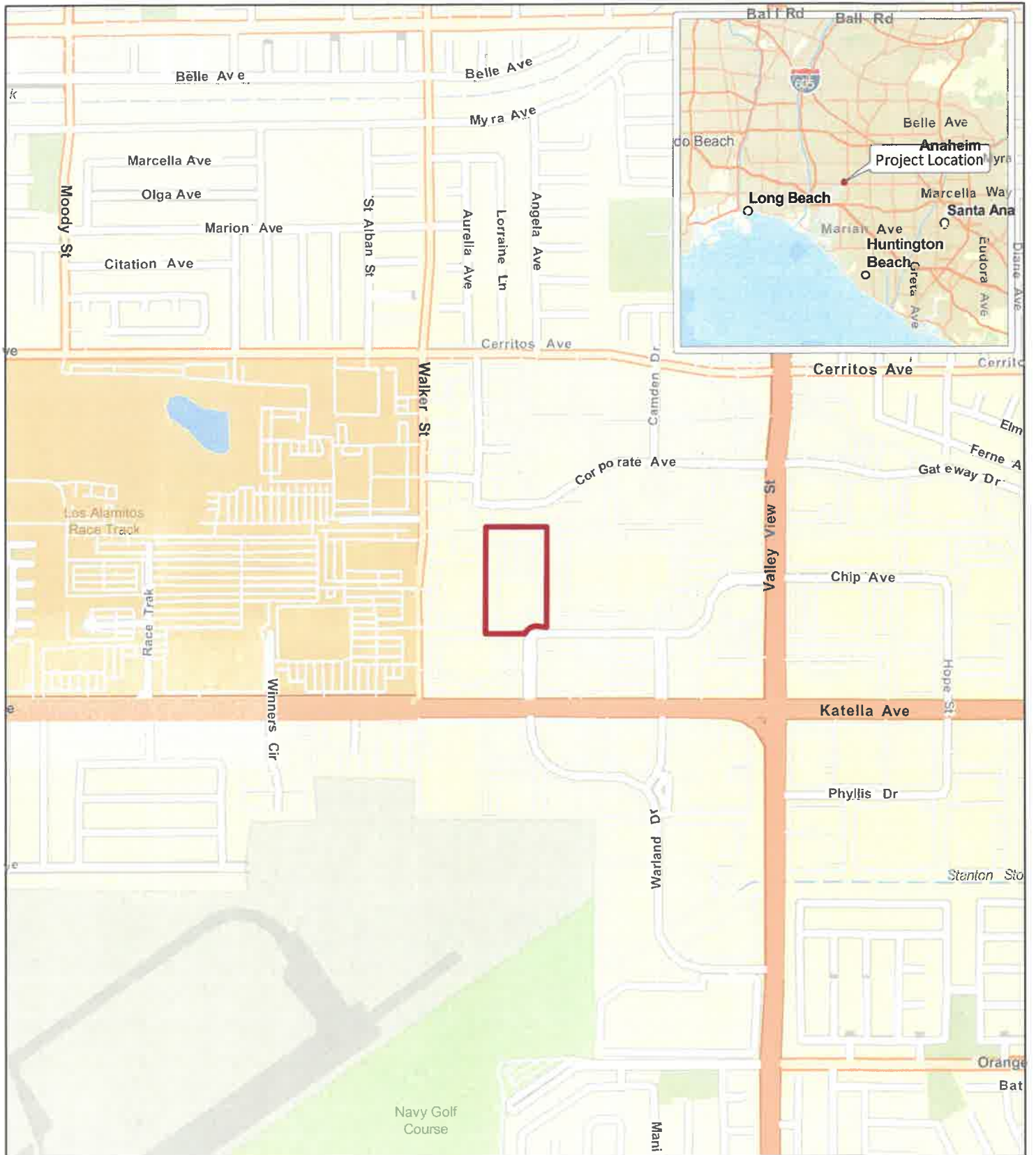
